- In fields having soils with less than 15% field moisture holding capacity, special care must be taken not to over-irrigate, since substantial over-irrigation promotes the leaching of chemicals.
- Do not apply Epic DF Herbicide in the following counties in South Dakota: Bennett, Butte, Fall River, Gregory (South of US Highway 18), Harding, Jackson (South of White River), Lawrence, Mellette, Perkins, Shannon, Todd, and Tripp (South of US Highway 18)
- If the water is less than 25 feet below the ground surface, do not apply Epic DF Herbicide to a field where any portion of a field contains an occurrence of a vulnerable soil. Vulnerable (restricted) soils are those soils that have an average organic matter (in the top 12 inches) of less than 2% by weight with surface and subsoil textures of sandy loam, loamy sand, sand or gravel; including modified versions of those textures.
