The purpose of this e-mail is to follow-up on commitments made during our conference call on 11/25/03.

- 1) At your request I have attached an electronic copy of the Order that establishes the ECA.

As I recall this was the only outstanding deliverable on my to do list.

Please know that since our 11/24 teleconference that I have been coordinating the EPA review of the redline mark-up on the fluoropolymer incineration draft ECA document. While this is on the fast track, I can not promise that we will have completed all the necessary internal discussions before the 12/10 Drafting Committee meeting but have already made significant progress.

- 2) Regarding our update report to the December 8 and 9 Technical Workgroup meetings. My present thoughts are that we should highlight progress made since the October meetings. Indicate that: 1) work continues on the various appendices and attachments, 2) that EPA circulated a draft ECA document, and 3) that FMG has submitted a redline mark-up on the draft ECA. For Telomers the focus will be on Appendix A development activities. As an additional item I will outline the tight schedule for the work that needs to be completed to make the appropriate January Plenary deadlines.

- 3) I'll be developing draft agendas for our discussions on 12/10, but my guess is that they won't be available until last minute. I'm confident that we will have enough to discuss. Let me know if you have agenda items other than the obvious that need to be included.
